Following your driving assessment, a report with recommendations concerning your ability to drive safely is sent to you, the Ministry of Transportation and your physician.

#### WHO IS ELIGIBLE?

Driving is an important and meaningful activity of daily living, however the ability to drive safely can be compromised by disease, trauma or aging.

If you have a medical diagnosis or condition that may affect your ability to drive then you are eligible for a driving assessment. Your license may still be valid or it may be suspended. You may have received a letter from the Ministry of Transportation indicating the need for you to be assessed at an approved driving assessment centre.

# **HOW DO YOU GET ASSESSED?**

A doctor's referral is <u>required</u> for you to be seen for an assessment. (even if MTO is requesting the assessment). Referral forms are available through our office and on our website:

Prior to the day of your assessment you must obtain a vision report from an optometrist. You will need to bring the report with you for the driving assessment.

#### **OUR PROCESS**

The Driving Assessment is a 3 part process:

#### I. IN OFFICE EVALUATION:

Includes physical, cognitive and visuoperceptual assessment. Conducted by a registered Occupational Therapist (OT). (2 hours)

#### 2. ON ROAD ASSESSMENT:

Conducted by a certified Driving Instructor and the OT. (45 min.)

3. **DEBRIEFING INTERVIEW**: The client as well as any family members present (with client consent) will be debriefed on the client's overall performance. Appropriate recommendations will be made.

PLEASE NOTE: We are currently unable to accommodate clients who cannot transfer independently into a car or require a modified vehicle. Such clients will be referred to another assessment centre
